

If you want to send a care package to any of the addresses below, please follow these guidelines:

- 1) Be aware that my journal is about 2 weeks (or more) behind my actual location. My itinerary is a best guess, and may not be accurate. I may already be past the place where you are mailing your package. On the other hand, I may not make it that far at all.
- 2) Allow as much as 2 weeks for your package to arrive at its destination.
- 3) Unless otherwise noted, please send all packages Priority Mail only.
- 4) For various reasons, not all resupply locations will be good places for me to pick up unexpected packages. For example, Muir Trail Ranch charges a \$50.00 per package fee to pick up packages.
- 5) Please do not send any item that I will have to carry, unless I request it. Anything that I am unwilling to carry will be returned or discarded. Not all resupply points have facilities to send packages back home.
- 6) Please clearly mark the package with the words: Hold for a PCT hiker. Otherwise the package may be returned if I do not pick it up within 10 days. Also mark the package with the date I am expected to arrive at that location.
- 7) Please double check that you have the zip code correct.
- 8) Please address packages with my real name, not my trail name.
